OPERATING HOURS AT POLAND'S CENTRAL BANK AND POLISH CLEARING HOUSE FOR FILLING BANKING INSTRUCTIONS ON 24 and 31 DECEMBER 2012

Please note that **24/12/2012** is a normal working day at Polish Clearing House and Poland's Central Bank.

On **31/12/2012** there will be only 1st and 2nd clearing sessions in Elixir system that will take place at standard working hours of Polish Clearing House. The Euro-Elixir system will perform three clearing sessions that will also take place at standard working hours of Polish Clearing House.
